## 1. What We Collect

 Personal Information: names, contact details, ABNs, licences, insurance details, job descriptions, payment details, ratings.  Sensitive Information: only if required for safety compliance (e.g., health data under WHS), with explicit consent.

## 2. How We Collect

- From you: during sign-up, job posts, applications, ratings, and platform interactions.
- Automatically: device data, IP address, usage logs for security and improvements.
- From others: Stripe (for payments), Australian Business Registry (for ABN verification), insurance verification providers.

## 3. How We Use Your Information

- To operate the Platform (matching, contracts, payments, ratings).
- To verify compliance (ABNs, insurance, safety).
- To improve services through anonymised analytics.
- For marketing updates, only with your opt-in consent.

## 4. Who We Share With

- Other users: limited details required for jobs (e.g., contact details after a match, ratings for profiles).
- Service providers: Stripe for payments, subject to confidentiality obligations.
- Regulators: if legally required (ATO, SafeWork NSW, OAIC).
- Overseas: none without safeguards (e.g., contractual clauses, equivalent protections).

# 5. Storage & Security

- Data stored securely in Australia.
- Retention: 7 years for tax/payment records; 2 years for job data; otherwise deleted after 12 months of inactivity.

- Security: encryption, access controls.
- Breaches: if a notifiable data breach occurs, users and OAIC will be notified as required by law.

# 6. Your Rights

- Access/Correction: request via **admin@rateright.com.au** (response within 24 business hours, Mon–Fri, 9am–5pm AEST).
- Complaints: contact RateRight first. If unresolved, escalate to the OAIC (oaic.gov.au, 1300 363 992).
